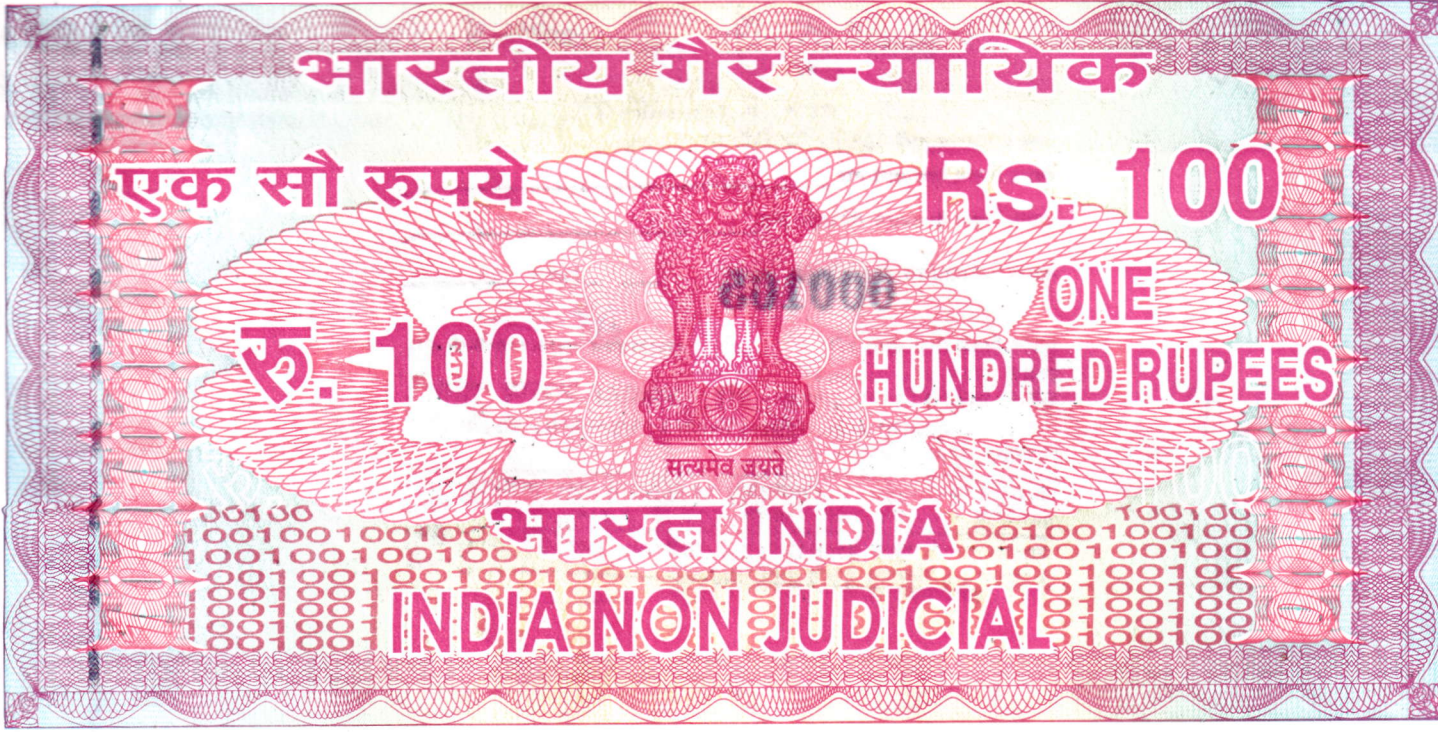

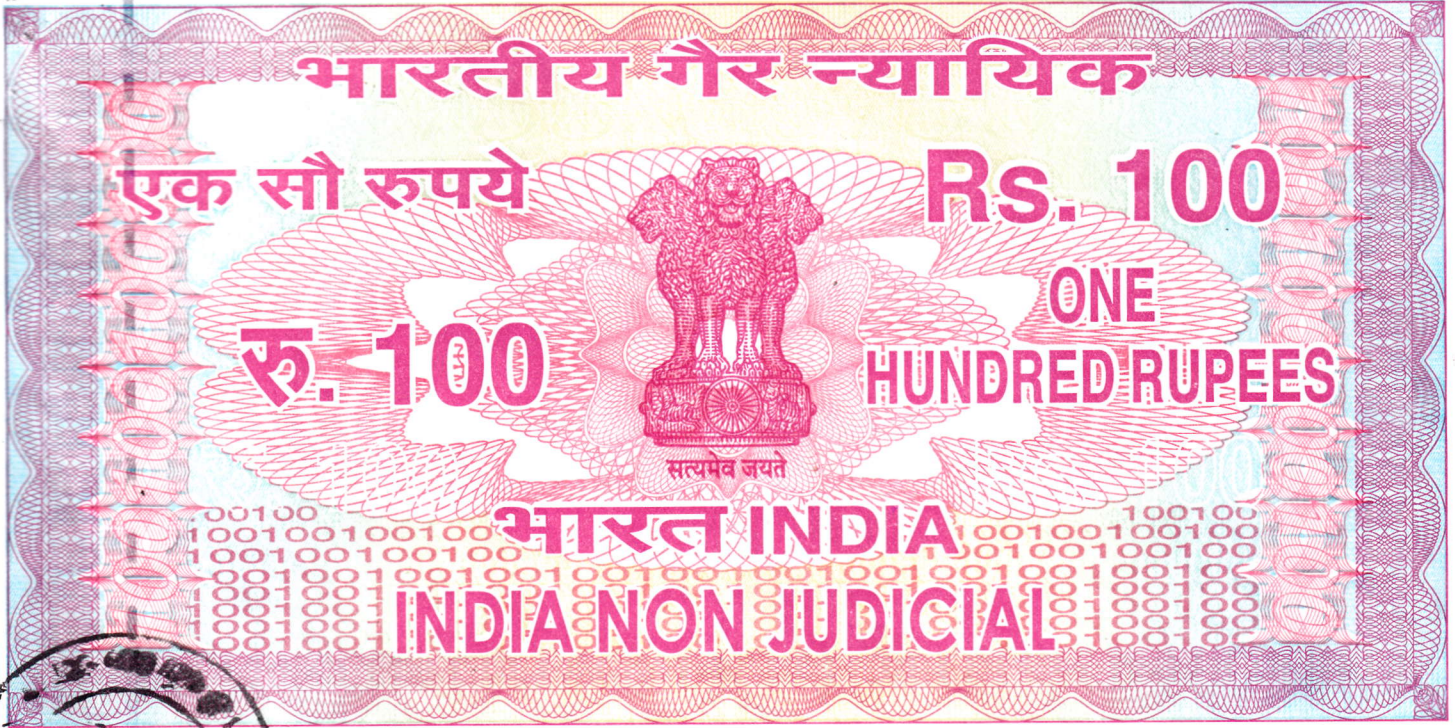

Now therefore, in consideration of the mutual promises set forth in this MoU, the parties here to agree as follows:



- 2) The second party will support the students of the First party on the Offline & Online programs that will be organized in collaboration with each other. They will also provide internship opportunities for students who complete the course and maintain a good academic record.
- 3) **Proposed Programmes:**
  - **Guest Lectures:** Second Party shall extend the necessary support to deliver guest lectures by industry experts to the students of the First Party on the Organizational and market trends and in-house requirements.
  - **Guidance on Campus to Career Transition:** The students will attend seminars, lectures and workshops in their early years to orient them regarding Corporate Security Management. In the third year (Semester V) they will undergo an advanced level course on Campus to Career transition to provide guidance on placements/internships by the Second Party to students who maintain a good academic record.
- 4) **Skill Development & Value-Added Programs:** Second Party shall train the students of First Party on the emerging opportunities in the field of Corporate Security and Safety to bridge the skill gap and make them industry ready through Value Added Courses, Seminars, Workshops or other training. First Party also agrees to facilitate this along with the Second Party, thereby ensuring its interested students in the first, second year and desirous students of the third year to enrol to its courses.
- 5) **Lifesavers Course –** A five days training program on Lifesaving to be conducted every year for a number of 75-100 students from the second years and third years.
- 6) ISSP will provide certification for each student based on the course curriculum and 100% participation by the student is must to eligible for any certification program.
- 7) **Financial Commitment:** There is no financial commitment on the part of the Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College. All Value-Added Courses, Seminars, Workshops or training will be borne by the Second Party based on the number of students, number of hours, skills taught to the students, hands-on training and will depend on the Industrial experts expectations.

Venkatesaperumal, hereafter referred to as “**DRBCCC Hindu College**” (which expression shall where the context so admits, mean and include its successors, representatives and permitted assigns) of the other part;

**WITNESSETH AS FOLLOWS:**

**Preamble:**

WHEREAS **MAHER**, a premier teaching and research institution in Health Sciences and having well qualified and dedicated faculty members specialized in Medicine, Dentistry, Physiotherapy, occupational therapy, humanities and sciences, Yoga and Nursing.

AND WHEREAS **DRBCCC Hindu College** is affiliated to the University of Madras and has around 100 members of faculty and 4000 students studying in various programs related to Arts and Science.

AND WHEREAS both **MAHER** and **DRBCCC Hindu College** are convinced about the mutual benefit of having formal linkage to provide training and support to faculty and students of **MAHER** on topics/subjects of common interest by **DRBCCC Hindu College** while **MAHER** shall provide manpower for conducting outreach activities including awareness programs, training in topics/subjects of common interest to faculty and students of **DRBCCC Hindu College**, and encourage faculty and student exchange program between the two institutions.

Now, therefore, in consideration of the promises and mutual covenants hereinafter contained, the parties hereto agree as follows:

**1.0. Scope of Collaboration and Responsibilities:**

1.1. **MAHER** and **DRBCCC Hindu College** after considering their objectives and strengths, agree to Sign this MOU in the following areas of interest

1.1.1. Members of the faculty and students of **MAHER** shall seek professional assistance from the Department of Statistics, **DRBCCC Hindu College** for their research projects on a consultancy basis for which fee shall be paid by the former to the latter. The fee for statistical work shall be fixed on a case to case basis and will be based on mutual agreement between the involved parties.

1.1.2. **MAHER** and **DRBCCC Hindu College** shall mutually invite members of the faculty of either institution as resource persons for workshops /Seminar/Continuing education programs on Basic and Advanced Statistics, Criminology, Forensic medicine, Forensic dentistry and other subjects which are of common interest to both parties.

1.1.3. **MAHER** and **DRBCCC Hindu College** shall pass information regarding various workshops and conferences related to Statistics, Criminology, Forensic medicine, Forensic dentistry and other subjects which are of common interest to both parties and invite each other whenever such programs are being hosted in their respective institutions to facilitate faculty and student participation

1.1.4 **MAHER** and **DRBCCC Hindu College** shall explore possibility for student and staff exchange programs to facilitate training in areas which are of common interest to both parties.

1.1.5 **MAHER** shall allow the students pursuing Master in Social Work to complete their Internship/Observership by posting them in Medical, Dental and Nursing Colleges for the period of time as required by the stipulated norms.

1.1.6 **MAHER** shall provide manpower and conduct outreach activities through medical, dental, nursing, physiotherapy, occupational therapy and yoga camps as well as awareness programs in the villages adopted by **DRBCCC Hindu College**. Both the institutions shall engage in creating a Community Lab to identify bio-social causes of disease and explore means to address the same.

1.1.7. Basic preventive and treatment services will be carried out at the camp site during the outreach activities and for those patients who require extensive treatment shall be provided with a referral card to **MAHER** or its constituent colleges. Patients who report to **MAHER** or its constituent colleges shall be provided the needed treatment and the cost for such treatment will be at nominal rate to be fully borne by the concerned patients or their family. The fee for such services which is availed at **MAHER** or its constituent colleges will be the same as applicable to all out-patients of **MAHER**.

1.1.8 Both **MAHER** and **DRBCCC Hindu College** shall explore possibilities for collaborating in activities related to NSS, Reb Ribbon Club and other social activities.

1.2. Specific terms, conditions and procedural aspects of collaboration under this MoU shall be finalized on mutual discussion.

1.3. A two member Steering Committee shall be constituted, one member each nominated by **MAHER** and **DRBCCC Hindu College** to identify the specific areas and coordinate the collaborative activities under this MoU. The Steering Committee shall consist of the following members:

On Behalf of **MAHER** : Dr. Shyam Sivasamy

On Behalf of **DRBCCC Hindu College** : Dr. Rajendra Naidu

The committee may be modified/reconstituted as per operational needs and responsibilities.

## **2.0. Confidentiality**

2.1. Both parties here under agree that any information disclosed under this MoU shall be maintained as confidential information and that such information shall be disclosed only to the statutory authorities if required. All such information shall be kept in confidence and the party receiving such information agrees to prevent disclosure to any other person(s) except to the person authorized by either of the parties on need to know basis for execution of work under this MoU.

## **3.0. Non Exclusively:**

Nothing in the terms of Agreement shall restrict either party from having such arrangement with any other institution.

#### **4.0. Monitoring, Reporting & Evaluation:**

Both the institutions shall meet once in three months to monitor, report and evaluate the progress as envisaged under the MoU.

#### **5.0. Duration:**

This Memorandum of Understanding shall be valid for a period of five years from the date of signing. This MoU is deemed to be renewed unless and until either parties gives the notice of termination.

#### **6.0. Termination:**

Notwithstanding clause 5, this MoU may be terminated by either party by giving three months notice in writing to the other party. Either of the parties shall honour within a mutually agreed period, the outstanding commitments, if any, as on the date of termination. Such termination shall in no manner affect the mutual right on maintaining confidentiality of patient details maintained till then.

#### **7.0. Notices:**

All notices and other communications required to be served under the terms of this MoU shall be considered to be duly served, on **MAHER**, if the same is delivered at, or posted by registered mail to No. 12, Vembuliamman Koil Street, West K.K.Nagar, Chennai – 600 078. Similarly, any notice to be given to **DRBCCC Hindu College**, shall be considered as duly served, if the same is delivered at or posted by registered mail to **DRBCCC Hindu College Darmamurthi Nagar, Pattabiram, Chennai – 600 072.**

#### **8.0. Modification:**

No modification to this MoU shall be binding unless it is made in writing and signed by both parties.

Our College is situated in the Chennai. The College campus consists of Six Blocks, Library, Computer Labs, Electronics Lab, Visual Communication, Multimedia Lab, Commerce Lab, Auditorium, Generator, Women's Waiting Hall, NCC Parade ground, NCC Obstacles Court, Play Fields, Vehicle parking sheds and temple. Our students are trained for holistic development and empowered with necessary skills to face the society. The college has the committees of Ragging Redressal Cell, Campus discipline and Students grievance redressal cell. The college has membership with other institutions like Andhra Chamber of Commerce, Hindustan Chamber of Commerce, Madras Chamber of Commerce and Industry, ICT Academy of Tamil Nadu, American Library, British Council Library, Madras University Library and ICSSR.

### 1. Scope of Collaboration

UWC would be collaborating with the esteemed Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College from 22<sup>nd</sup> January to 31<sup>st</sup> January 2024 with the time slot allocated from 12 PM to 5.30 PM each day for 118 final year students to enhance the employability skills of students through Work Readiness and Soft Skill Training for pursuing final year of their degree to increase their chances of securing sustainable employment. A Classroom-based, in-person training is designed to maximise student experience and help students hone their skills through practice. The following are the highlights of the planned activities:

- A. Batches of 40-50 students each will be formed.
- B. Industry experts and experienced trainers will be engaged to deliver the course.
- C. A structured curriculum aligned with industry requirements and student needs will be delivered.
- D. Each batch will undergo ~ 40 hours of training.
- E. All students to be introduced to resume preparation & receive mock interview support through UWC team and CIS Experts.
- F. UWC will conduct regular assessments and evaluations to measure the progress and impact of the initiative.
- G. UWC will provide the necessary resources, materials, and infrastructure to support the successful implementation of the program.
- H. UWC will not provide any stipend or any other monetary support to the beneficiaries
- I. Termination of the agreement by UWC if the clauses are breached by the college.

The collaboration between United Way of Chennai and **Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College** will include the following activities: Prioritize problems/challenges the colleges want to address, understand and review together the current Training and Placement plan of the college and focus on building the placement network, jointly develop/co-create general interview questions etc., have a continuous feedback loop to maximize the intervention outcomes etc.

#### a) **Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College** will:

- i. Get into a mutual contract agreement to take the intervention forward
- ii. Allocate time slots in college timetable for the 22 sessions and 2 full day workshops for the Mock-Interview & Resume' Reviews
- iii. Support in terms of providing infrastructure & other logistics to run the classes
- iv. Help ensure student attendance and support in smooth completion of the program.
- v. Be involved in the program and provide valuable inputs/share feedback/co-create resources etc.
- vi. Facilitate the training program by providing the list of student's beneficiaries who would be attending the program to be provided by the college prior to the program
- vii. Ensure the participation of students in the training programs. The minimum number of 50 students should be present in each batch and students' attendance sheet will be tracked and maintained.
- viii. Allocate a SPOC (faculty representative) from the college who would be coordinating for the entire program and to moderate the project for smooth implementation, overseeing, providing inputs and resolving any challenges.
- ix. Fix training timing and assemble candidate, monitor and maintain the attendance during training sessions

- xi. Ignition inaugural and valediction will be conducted on the day of commencement and closure as applicable
- xii. Feedback based appreciation certification for the entire training & placement will be assisted
- xiii. Provide permission to collect relevant student data on an ongoing basis for program monitoring, evaluation and CSR audit purposes.
- xiv. Providing Candidate Placement database with United Way of Chennai after the Completion of the Training Program
- xv. Consent for taking photographs of the students during the program and using the same for reports publishing/social media

**b) CIS will :**

- i. Provide technical and soft skills training to students of Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College on mutually agreed curriculum (Curriculum outline attached as annexure).
- ii. CIS will support UWC by providing necessary reports and assisting UWC in Baseline and end-line assessment with college management and students
- iii. Monitoring the progress of students through assessments and providing feedback to Dharmamurthi Rao Bahadur Calavala Cunnan Chetty's Hindu College on a regular basis so as to ensure effective implementation of the training.

**3. Term of MoU:**

13. Students of study centre shall be allowed access to the library of concerned department in which the study centre has been setup.
14. Members of Central Council, Regional Councils of ICSI or Members of the Chapter Managing Committees are not eligible to act as Faculty in the classes conducted by Study Centres.

**WHEREAS, 'DRBCCC HINDU COLLEGE' is affiliated to University of Madras and has around 130 members of faculty and 3500 students studying in various U.G, P.G and Research programs related to Arts and Science and whereas 'TNIUS' with its principle objectives of a) to create an awareness of the need for the application of latest management techniques in various branches of Municipal Administration; b) to carry out research with a view to develop knowledge in the field of municipal administration and to adopt knowledge developed in other states in respect of municipal administration to suit the conditions prevailing in Tamilnadu; and c) to disseminate knowledge on municipal administration and urban development through seminars, conferences, journals and other publications.**

**AND WHEREAS 'TNIUS' which was established in 1981 and recognized research institution of Bharathiar University, [State University of Tamil Nadu] empanelled Training Entity of Government of India under AMRUT scheme.**

**AND WHEREAS both the Institutions work with objectives to enhance quality of training and learning process, research and extension of services to the public sector working society at large and whereas both DRBCCC Hindu College and TNIUS are convinced about the mutual benefit of forging formal linkage to develop collaborative training, Seminar, Conference, Workshop and research programmes in the areas of their core competence with special focus on providing survey opportunities to students to learn about sampling techniques, Internship for the students to provide efficiency in data handling and to assist in showing way to the students for their career development in relation to Central, State and Local Body level;**

**NOW, therefore, in consideration of the premises and mutual covenants hereinafter contained, the parties hereto agree as follows:**

**1.0. Objectives of collaboration**

**2.2 Twinning capacity building programmes**

**To facilitate and to run capacity building programmes in a twinning mode by exchanging faculties and participants of the programmes between DRBCCC Hindu College and TNIUS;**

**2.3 Seminars, Conferences and Workshops.**

**To organize jointly Seminars, Conferences and Workshops in the field of area Municipal Administration and Water Supply Department (General administration, Finance, Public Health, Town Planning, Engineering, National Urban Livelihood Mission and Taxation).**

**Schemes: AMRUT, Smart cities, SBM, NULM, Climate Change and major schemes implemented by both State and Central Government.**

## **3.0. Confidentiality**

**3.1. Both parties hereunder agree that any information disclosed by one party to the other while carrying out collaborative activities under this MoU shall be maintained as proprietary confidential information and will be disclosed only to the authorities as required in the relevant statutory regulations and to those persons in the recipient party's organization on a 'need to know' basis only.**

**3.2. All such proprietary confidential information will be kept in confidence and the party receiving the confidential information agrees not to disclose to any other person or persons outside the organization or any unauthorized person or persons except to the organization authorized by either of the parties hereunder on 'need to know' basis for the execution of the collaborative work.**

## **4.0. Intellectual property rights [IPR] protection**

**4.1. IPR generated during the activities under the MoU shall be shared jointly. The extent of ownership shall be decided mutually depending upon the relative level of intellectual inputs made by the parties.**

**4.2. Both parties shall not file any application for seeking IPR/Patent in its own name or in the name of its associates or any other person(s) on any matter relating to the information developed under this MoU. However, they can seek intellectual property**

rights on joint names of the parties as may be mutually agreed, on case to case basis.

4.3. The above principles will apply to all the activities of IPR such as patenting, technology transfer and commercialization of invention developed out of the activities covered under this MoU.

**5.0. Publication**

**8.2. Notwithstanding sub-clause 8.1., this MoU may be terminated by either party by issuing a two months notice in writing to the other party prior to the desired termination date. However, both parties agree that all continuing obligations to trainees, students, staff, funding bodies or other entities are met in full subsequent to the notice of termination.**

**10.1. No modification to this MOU shall be binding unless it is made in writing and signed by both parties.**

**10.2. If any provision of this MoU is held by any Court or other competent authority to be illegal, void or unenforceable in whole or in part, this MoU shall continue to be valid in respect of the other provisions thereof.**

**10.3. Nothing in this MoU shall constitute, or be construed, a party as the partner, agent, employee or representative of the other party. Either of the Parties hereto must not act independently of the other Party and does not have the right or power to commit the other Party on any matter or incur any obligation on behalf of the other Party without the prior written approval of the other Party.**

**10.4. Each of the parties hereto agrees to comply with all laws applicable to the party concerned in respect of the activities undertaken in pursuance of this MoU.**

#### **11.0. Arbitration and Jurisdiction**







6. Placement of Trained students: Second Party to facilitate placements for at least of few students if feasible.





3. DHARMAMURTHI RAO BAHADUR CALAVALA CUNNAN CHETTY'S HINDU COLLEGE is an organization furthering the Educational activities for Students from far flung in and around state for building their career. The product to be produced by PMEGP beneficiaries and sold by DHARMAMURTHI RAO BAHADUR CALAVALA CUNNAN CHETTY'S HINDU COLLEGE/KVIC will depend on marketing of product and the demand for the same.

(vi) KVIC will provide identified cluster list to DHARMAMURTHI RAO BAHADUR CALAVALA CUNNAN CHETTY'S HINDU COLLEGE, so that DHARMAMURTHI RAO BAHADUR CALAVALA CUNNAN CHETTY'S HINDU COLLEGE can plan setting up of PMEGP units of students and dependents and take advantage of KVIC schemes viz, SFURTI, PRODIP and RISC etc., as per eligibility conditions.

### **AREAS OF COLLABORATION**




F. The second party (PI) will document and show case the development outcomes enabled by their planning and handholding of its implementation in the respective panchayats by using appropriate media and technologies.
